#### Dear Friends in Christ,

Our synod staff and synod council have been using the phrase Wellsprings of God's Love to describe ministries across the beautiful and vast Northwest Intermountain Synod. In our two-page document about what we do together as a synod, you'll read, "As the waters of our synod all flow into streams and creeks that run into the Snake and Columbia Rivers, our ministry sites make up a watershed proclaiming the life-giving gospel of Jesus Christ." Using the phrase Wellsprings of God's Love is meant to be descriptive, not prescriptive. In other words, we do not want to give you one more thing to do or be. The phrase comes out of who you already are, which our staff observes as we travel throughout the synod. Furthermore, a wellspring implies abundance, and we trust that such abundance is possible because of God's love made known to us through Jesus Christ. Whether you are in a rural community or a more urban area, your ministry might feel isolated; you are not. The waters above ground and the aquifers below keep us connected as one synod, one church. Wellsprings are not isolated, and neither are our ministries!

Our scripture guide for Wellsprings of God's Love comes from John chapter 4: Jesus' encountering the woman at the well. Jesus uses the phrase "living water" for the Holy Spirit that meets people's thirst for life in relationship with God. Ultimately, that is what ministries in our Northwest Intermountain Synod do, help people be in relationship with the loving God we worship. Whatever that looks like in your context, thank you! And thank you also for your gifts of Mission Support. Because of Mission Support from congregations like yours, our entire synod can collectively help people build and strengthen their relationships with God. When we gather online for our Synod Assembly, Saturday, May 3, we will use John 4:7-15 as our central text. Further along in the story, in verse 29, the woman says to the people in her city, "Come and see a man who told me everything I have ever done! He cannot be the Messiah, can he?"

As you celebrate the ministries in your own congregation from the past year and look ahead to the new year, I encourage you individually and collectively to wonder and commit to who you will proclaim, "Come and see!" Who in your sphere of family and friends has no idea that a Wellspring of God's Love even exists? Who needs a place of welcome? Who has no clue that God's love is absolutely without a doubt for them? Who is parched from the daily grind of life? Telling someone about God's love can be scary. Inviting someone to join you for worship or a potluck might be overwhelming. Consider how you have experienced your congregation, or one like it, as a Wellspring of God's Love. That is your story, your truth. And then you can be bold to say, "Come and see!"

#### Worship

Our Worship Committee is truly wonderful group of people who love worshipping God. They give feedback and suggestions at each monthly meeting. Several of the committee members have also been on Worship Planning Teams.

- I am very appreciative of those members who volunteer for our Worship Planning Teams for each season of the Church year. They read the scriptures for each Sunday, and read the theme for each week and then search for songs and hymns that match the theme. When the team meets we sing the tunes, look at the words of a hymn and how it lifts up the theme for worship. There is laughter and storytelling as we share song favorites.
- During 2024 we have instituted a time of silence before worship starts. The prelude starts at 9:50 and then at 9:55 there is a message on the screens that invites people to start a time of silence to prepare for worship to begin. This time of quiet meditation and prayer has been helpful for the worship leaders. This also helps our online people because there are microphones in the sanctuary that pick up conversations before worship starts. The quiet helps the people on the Live Stream and those viewing a video to also prepare for worship. We have learned that conversations in the sanctuary before worship are not confidential.
- We have GREAT writers in our congregation and I am extremely grateful for Mary Rickerd and Dawn Lewis who have written prayers for worship. They both has a strong faith and their writing adds greatly to our worship.

#### **Young Adult Gathering**

Katie Vaage, (Sponsor) Eric, Fabrice, Paterne, Junior, Aurelie, Ornella, and Reuben. This was a fantastic trip for these young adults who traveled to New Orleans and joined together with other young adults in the ELCA. They learned and they listened to speakers at the large group gathering each night. They sang, they danced, ate good food and had many new experiences. ## 2024 Annual Meeting Minutes

#### King of Glory Annual Meeting: January 28, 2024

Council President Becky Newberry called the meeting to order at 11:32 AM

Pastor Connie began with an opening prayer.

A quorum was verified with 50 confirmed members present in person and three households on Zoom.

#### Pastor's Report: Pastor Connie Winter-Eulberg

Pastor Winter-Eulberg's report is contained in the 2024 Annual Report.

The Pastor noted appreciation for many of the volunteers who have stepped forward in 2023.

#### Council President's Report: Becky Newberry

The Council President's Report is contained in the 2023 Annual Report.

Becky highlighted the forward-thinking visioning produced by Steve Eulberg's "I Have A Dream" session. These included things we hope to have accomplished during 2024 and over the next three years.

#### **Committee Reports:**

No further discussion or questions on the Committee Reports contained in the Annual Report.

Approval of the minutes from the 2022 Annual Meeting and the June 2023 Mid-Year Meeting. Carolyn-Jean Smith moved to approve the minutes, Todd Kraft seconded the motion. Passed by show of hands, none opposed.

**Congregational Ratification** for 2 Constitutional Amendments (Chapter 11 & 12) passed in June 2023 at the Semi-Annual Congregational Meeting. [Protocol required by the ELCA and the Synod for our constitution changes had not been followed previously and we are now correcting that oversight to be in compliance.]

- 3. A continuing resolution was added in Chapter 18, which references the update made in Chapter 12 for the number of members-at-large on the Congregational Council.Currently, the number is 2 members-at-large.

Becky Newberry reviewed the constitutional changes that were approved by vote at the June Mid-Year Congregational meeting:

- to allow the treasurer a voice and vote on Council
- to define the Congregational Council to consist of the Pastor(s), the executive committee plus a range of 1-4 at-large members of the congregation.

Nicki Tompkins moved to ratify the constitutional changes. Nancy Seversen seconded. A show of hands was counted to ensure a greater than two-thirds majority voted affirmatively. None opposed.

#### 2023 Financial Reports: Carolyn Jean Smith, Treasurer

Carolyn–Jean reported that this year was the first year the checking account balance more than covered the amount in designated funds. Were all the designated funds to be spent, it would not have left us in the red. She has spent much of the year getting established with a new accounting firm and bringing them up to speed on how we do our accounting. Overall, in 2023 we spent \$388,884 from a budget of \$417,000.00. Actual income was \$424,091.09. The financial reports are included in the 2023 Annual Report Addendum.

## 2024 Annual Meeting Minutes (continued)

#### 2024 Budget Report: Dan Price

The 2024 budget has been reviewed and approved by the Finance Committee and Council. The 2024 budget is a balanced budget. We received 67 pledges totaling \$366,104. There are increases in salary for all Church Staff. There is an increase in Bookkeeping & Accounting Services to cover increased expenses. There is an 8% increase in Benevolence giving for the first time in several years. This Benevolence includes both for the NWIM Synod and for Luther Heights Bible Camp. The Worship Committee budget is increased to cover the music program, and copyright fees were moved here from the Administration category.

Mary Kay Tinker moved to accept the 2024 budget. Dawn Lewis seconded. Passed by show of hands, none opposed.

#### **LEAP Affordable Housing**

Becky Newberry and Todd Kraft reported on the current status of the LEAP pocket neighborhood and access for Veolia for a new Community well to be drilled. Two meetings have been held with our neighbors, and some of the planned structures will be rotated to allow greater privacy for those neighbors. The plans call for three duplexes and two single unit houses for a total of eight Affordable Housing Units. Because the LEAP parcel will be sold instead of leased, the city requires a "flag lot" allowing access to Maple Grove Road. Thirty (30) feet south from the north boundary will be "cross access" ownership for the 'pole' of this flag lot. Footpath walking access will be required between Maple Grove Road and the Pocket Neighborhood. LEAP has filed with the City of Boise for the appropriate zoning to create this Pocket Neighborhood.

The meeting was concluded with the Lord's Prayer, prayed in unison.

Dan Price moved to adjourn the meeting; Patty Larson seconded. The vote to adjourn was by show of hands, none opposed.

The meeting adjourned at 12:34 PM.

### Christian Education 2024

#### **Youth Education**

- In 2024, the Christian Education Committee sponsored Sunday school, Adult education, and a Christmas program. They also continued with mailings of the Spark Family Magazine, Cradle Role and slowly adding to the little books of the Bible for Middle school age.
- In the spring we continued one class for youth ages 3 to 6th grade, taught by Coletta Hill & Phyllis Bradburn, the format that we had started in the fall of 2023. Doneta Stephensen, Sally Husted, Shirley Dodson have been substitutes. We used the ELCA All Kids Spark Activate Faith (green) series. In the fall this format was continued. There have been 16 students attending, at various times, usually having 7 or 8.
- Currently we have 2 children of Cradle Role age (Newborns thru age 2) we are sending out Splash monthly Newsletters to the parents of only one, to a family who has not previously received the newsletters.
- For the children ages 3 -8 we were mailing 11 copies of Spark Family every 3 months, but the magazine ceased publication after the September issue. So that program has been discontinued.
- For those who were in 4th to 6th graders during the covid break in 2021, I continued to
  make tiny books of the Bible, sending 6 or so at a time with a lesson sheet about the books
  to 10 students. There are 7 books left to complete the set, and all but Revelation is ready to
  print.
- Confirmation classes continued with Pastor Connie in conjunction with the other ELCA congregations in the valley.
- ·Katie Vaage and Erik Vaage and 9 youth /young adults attended the ELCA national youth gathering held July 16-20, or 23-26 2024 in New Orleans with the theme "Created to Be," taken from Psalm 139.
- Some were attending the young adult gathering for ages 18–25 which was added because many missed the chance to go to the last youth gathering which was cancelled.
- Six youth, from grades 2 thru high school, attended a week at Luther Heights Bible Camp this summer, a much-anticipated repeat activity. Lynne and Angeline were also in the camp leader in training program. Katie Vaage, Sally, Gabrielle and many others in the congregation helped to make this happen.
- In September we continued the combined Sunday school class for ages 3 through 5th grade. We are using the Spark All Kids Sunday school curriculum. The teachers are Coletta Hill, and Phyllis Bradburn. Doneta Stephensen and Sally Husted have been substitutes
- In December, Luther Heights provided an inclusive Advent afternoon at King of Glory, for all ages including all the ELCA churches in the Treasure Valley.

#### Youth Education (continued)

- Coletta Hill again led the youth in telling the Christmas story during the Christmas Eve family service. The youth dressed in Biblical costumes (from previous years) and briefly acted out the Christmas story. The youth concluded with a drum rendition of the "Little Drummer Boy" lead by Steve.
- Steve Eulberg has been not only concluding the youngest class with ten minutes of drumming practice, he has also provided the middle schoolers with a Sunday morning drumming class during the Sunday school hour.

Doneta Stephensen has been responsible for lining up Sunday morning classes which have been provided by various groups and individuals. Classes have been taught by Ann Palma, Mary Kay Tinker, Gretchen Bingea, and Mary Rickerd. Other adult activities are available independent of our committee.

## Director of Music Report 2024

Martin Luther was quoted as saying, "Whoever sings prays twice." At King of Glory this past year I can affirm that since a LOT of singing has happened, even MORE prayers have been lifted up. "Equipping the Saints" to share their musical gifts is my goal and delight.

With the return of our Bells from their loan to Covenant Presbyterian, our **Chimes Choir** has fully transitioned to our **Bell Choir** and its ranks have grown. We rehearse weekly and have provided musical leadership in our worship about once every 6 weeks. The **Vocal Choir** has been steadily adding to our repertoire and have shared many new anthems from **All Creation Sings**, as well as taking part in the MAP congregations' *Holy Week* worship and *Christmas Concert* at St. Paul Baptist Church. The Choir is preparing new anthems from **This Far By Faith**, the Lutheran African American Hymnal which celebrated its 25th anniversary last year. Thanks to a grant from our WELCA, we were able to purchase copies for the Choir.

In the Fall I began a Praise Lab after worship on Sundays to equip our middle school youth as percussion leaders. Together we then lead the weekly Sunday School Closing in the sanctuary. This is the basis of our Youth Percussion Choir which also provides leadership in our Sunday Worship, and provided special music for the O Holy Night Christmas Concert at St. Paul Baptist, and they played a featured role in our Christmas Pageant.

The roster of our weekly worship musicians has also grown to include Jorgen Vaage (drums), Sam Alessi (guitar), Ken Grove (organ), Lawson Rocke (also sax and piano) and Hudson Rocke (guitar). We have been well-served by substitute musicians, Del Parkinson, Mary Rickerd and Ken Grove. Here is a reminder and invitation: there is *always* room at this table for the instrument(s) YOU play!

We were blessed to host several outside musicians this year as well: Mountain Dulcimer Quartet, Erin Mae Lewis and the Treasure Valley Musik Meisters for Reformation. We have introduced and explored two new liturgical settings **Light Into the World Bluegrass**, by Kent Gustavson, and **Christ Is Our Peace**, by Steve Eulberg.

# Director of Music Report 2024 (continued)

We have finalized our audio/visual upgrades with AVI-Neurilink with monitors for the leaders in the chancel and for our musicians; we've traced down and fixed issues with the speakers throughout the building; we upgraded our piano sound with a matched set of piano microphones that help the AV pilots provide balanced sound. The summary of our faithful monthly service commitments includes interior and exterior building maintenance, roof patrol and groundskeeping. Our budget is broken into these five categories: Inspection/Monitoring, Landscaping, Maintenance & Repair, Supplies, Utilities. We receive monthly reports on expenses from our Church Treasurer, Carolyn Jean Smith.

Improvements seen in 2024 include the installation of carbon monoxide monitoring devices around the church building (thanks to Katie Vaage's Thrivent Action Team Project); replacement of the existing toilet in the sacristy restroom (now known as the All-Gender Restroom); removal of a diseased pine tree on the church's back lawn. Relocation of regular building users: The Life Ahead was moved to the Forum and the Bethlehem room repurposed for AARP use.

Our building maintenance and inspections include support from several reliable vendors. ACCO Engineering Systems supports the repair and maintenance of the eleven HVAC RTU's (Roof Top Units). There was an opportunity to combine the inspection services of four different vendors into one 5-year contract with Crane Alarm, resulting in an overall contract savings of 25%. Curtis Clean Sweep remains our parking lot support vendor for snow removal and planned resurfacing and restriping after the LEAP/Veolia Projects are completed.

Because we have not been able to recruit additional younger volunteers from our congregation for summer lawncare and winter snow removal, we are currently contracting with Idaho Premier Lawncare for this support.

As we have heard before, "it takes a village" to keep King of Glory a vibrant and active part of our community. We encourage you to consider becoming a part of the Property Committee in 2025. We meet monthly for property task-planning meetings on the second Thursday of the month. Saturday morning Work Days, follow that Thursday evening meeting, between the months of March and November, weather permitting. As an additional perk, Lynda Cambron coordinates food donations and serves a delicious lunch at the end of each Workday. Jack & Becky Newberry are committed to co-chairing this committee through 2025 (our third year at this position) and then will step down to give others an opportunity to chair this committee.

## Social Ministry 2024

## Community Garden 2024

Well, it was a bit of a change and a challenge for us this year! We lost some space due to the splitting of the parcel, which included not only a large swath of three gardens and a pathway, but our precious working and finished compost piles. However, we still have 21 plots for families to use to grow food.

I got the new irrigation pipe cut and moved, and a new pathway laid out to match the new space, so we should be ready for any construction next year. We successfully moved the free city compost pile to where one of the peach trees was, and will utilize that spot in the future also.

We tried putting mid-season debris in the church dumpster, but the dumpster was immediately overwhelmed, and at one point became a combustible hazard due to the compression, heat and rapid decay of hundreds of pea plants. I

I am wrestling with the idea of forbidding our gardeners' cultural practice of succession planting, but because these gallons and gallons of dried peas are so important to them for food security, I am working on finding other ways of dealing with the loss of the compost pile.

We finally rented a dumpster for the rest of the season, and I am pretty sure that it has reduced the garden budget to zero, or close to it. I am afraid to get an actual number!

With help from Doneta Stephensen, I did work out a location for a new compost area between the garden shed and the back fence bordering the current Veolia property. This should meet our needs pretty well. May thanks to Jack Newberry for prepping the site!

We still need to cut a new door in the yellow garden shed and fence the area to contain the compost, and I will start on that as soon as the weather warms up.

One of the water tanks has a leaking faucet, and I will attempt to repair it in the spring also, but considering these tanks are not designed for permanent use, it may not be feasible. We can easily get by with one tank if needed.

## Community Garden 2024 (continued)

Our hose reel broke this summer, and bundling up 350 feet of hose after filling the water tanks is tricky, but I did buy new hoses last year that are much lighter weight than the old hodge-podge of leaky hoses.

I had a discussion with the gardener who has enjoyed planting way too many tomato plants, and hopefully they can restrain themselves a bit next year.

Regarding the tomato plants, we have been struggling a bit with the theft and vandalism of garden produce. Most of the gardeners are growing things that do not appeal to thieves, so unfortunately the prime targets have been our sweet little Russian gardener, and the tomatolover. I know there has been talk that increased activity may help reduce the problem, but the thefts are not occurring during the day when activity is likely to take place, so the church may need to consider fencing the garden in the future if the vandalism (including an apparent tomato fight!) and theft do not resolve.

## Mission Endowment Fund (MEF) 2024

The calendar year of 2024 for the King of Glory Mission Endowment Fund was another year of promoting the fund, encouraging contributions and revising and updating the Policy and Procedure Manual. The following individuals were pleased to serve as your Endowment Fund committee during the year.

The purpose of the fund is to establish a permanent endowment fund to accumulate gifts, bequests and income and to distribute the net annual income from the fund for the following purposes:

Twenty percent of the net annual income will be allocated to outreach in the community and Synod. This will include social service agencies, institutions and other agencies to which the congregation relates and special programs catering to the needs of people in southwest Idaho who are in spiritual or economic need. These programs can include the homeless, jobless, chemically dependent, victims of violence, unwed mothers, boys' and girls' clubs, orphans and foster children, the elderly and many others.

Twenty percent of the net annual income will be spent in North America and/or worldwide for missions of the ELCA for outreach. This will include grants to the ELCA for new congregations, leadership, training, education, global missions, ecumenism, evangelism, social ministries and capital financing.

Twenty percent of the net annual income will be spent for capital improvements or a building program for King of Glory.

The balance of the net annual income, representing forty percent, may be added to any one or all of the above areas. The committee shall determine the allocation for causes and programs consistent with the Endowments Fund's purpose.

## Mission Endowment Fund (MEF) 2024 (continued)

In 2024 the endowment fund distributed \$6,479 in accumulated income to the following organizations and projects.

Safe Families for Children	\$1000
Lutheran World Relief	\$887
ELCA Good Gifts	\$1000
Camp Luther Heights	\$1000
King of Glory AV Pilots	\$1296
King of Glory Capital Improvement fund	\$1296

We are expecting a similar amount of accumulated income to be available for distribution in 2025 and encourage the congregation to submit suggestions to the committee prior to the end of January.

A major focus for our committee this year was the development of a policy and procedure manual for the endowment committee. The purpose of the manual is to ensure consistency in the administration of the endowment fund and the distribution of grants as described above. As of the end of the year this manual has now been completed and distributed to all committee members.

In September, the committee hosted a coffee hour and provided handouts explaining the purpose of the endowment fund and encouraging contributions. Anne also gave a temple talk at that service. In October, the committee encouraged members of the congregation to participate in an Eternal Hope-Earthly Conference workshop presented by Immanuel Lutheran Church which focused on issues around aging and estate planning concepts.

We will be losing two of our members at this annual meeting, Sandy Lieske and Ron Nearman. While we hate losing their guidance and input, we look forward to working with the new committee members elected at the annual meeting and welcoming them into our group.

The Endowment Fund has continued to grow this year, and we thank all those individuals who have made generous donations to the fund. The fund balances as of November 30, 2024 were: ELCA Endowment Fund Pooled Trust \$215,538.20; The Mission Investment Fund \$7,018.00; and the Edward Jones brokerage account \$490.69.

Over the years many of your fellow members have chosen to use the King of Glory Endowment Fund to reach out and promote the work of the church. As we move forward into 2025 the committee would like to encourage the congregation to prayerfully consider including the Endowment Fund in your charitable giving plans for the year. We are hopeful that the growth of the fund will continue to increase so that we can address the needs that we all see in our community and the world.

Please watch for more exciting events sponsored by the Endowment committee throughout the coming year and prayerfully consider how the King of Glory Endowment Fund can be incorporated into your overall plan for giving.

Among them are decisions regarding the music and musicians; people who work on the Altar Guild; Vocal and Bell Choirs; ushers and greeters; lectors and assisting ministers; kids' activity bags; ecumenical worship; and other worship activities which may occur during the year. Serving on this committee affords another opportunity for church members to be involved in the worship life of King of Glory. Together, we work for Spirit-filled and inspiring worship experiences for the King of Glory congregation, both in person and online.
