Council Actions and Information

Council Continuing Business

Several items of Continuing Business were addressed within the March Council Meeting.

- Council was asked by Steve Eulberg to modify our monthly meeting time, since there are several of us who also participate in music rehearsals on Tuesday evenings each week. We settled on the same day of the month (third Tuesday) but moved the start time to 2:00 pm with a projected finish time of 4:00 pm.
- Changes were needed in the membership of the Columbarium Committee because Gary Derr has asked to be relieved of his final year of service and Jim Stumpf, who had been elected at the January Annual Meeting, declined to serve. As a result, Sam and Pauline Alessi have indicated an interest in serving and Council unanimously approved their appointment, effective immediately.
- The Congregational Membership Roll needs an Annual Audit, per our Constitution, and we noted eight families who have adult children listed as active members at King of Glory, though they are not meeting the criteria stated in the Constitution. Three council members have volunteered to contact these families to offer other solutions for their adult children, including Associate Membership, if they so desire. Otherwise, we need to remove these adult children from the active membership database.
- Council members reviewed the list of volunteer Technology Tasks submitted by Matt Lee, prior to his stepping away in January for personal reasons.
- We came to an agreement with our daily-meeting AA group to replace the old toilet in the All-Gender Restroom with one that was more modern. The AA group contributed a monetary donation to help cover the expenses for this task.
- The KoG Wedding Guide document is being updated since it had not been reviewed since 2017.
- Council unanimously approved a proposal submitted by WELCA to use our church nursery area to provide babysitting services to Safe Families participants one day per week for three hours. This project will likely begin in June 2024.
