Dear Friends in Christ,

Welcome to annual meeting season! I hope that in addition to doing the important work of electing leaders and/or approving budgets, your congregation's annual meeting is a time to celebrate the way the Holy Spirit is working through your congregation and the many ways God's love is shared in your larger community, across the Northwest Intermountain (NWIM) Synod, and around the world. I am writing this letter in early January, after reading Christmas cards full of laments for Israel and Palestine, Ukraine, and so many other places where violence harms the innocent. But the letters also spoke of the deep hope that comes from trusting in the abundant love and life that comes from the Triune God we worship. I encourage you to rejoice in this hope during your meetings even as you pray for peace.

At the end of April, the NWIM Synod Assembly gathered under the theme Bega Kwa Bega (shoulder to shoulder). We use this Swahili phrase because Swahili has no word for *accompaniment*, the term the ELCA uses to describe companion synod relationships (like our relationship with the Ulanga Kilombero Diocese of Tanzania) and the many other relationships in our neighborhoods and communities. The scripture story at the heart of our understanding of accompaniment is the Road to Emmaus from Luke Chapter 24, which begins with Jesus walking should to shoulder with two disciples who do not recognize him. The teaching document on accompaniment states, "We, and our acquaintances on the road, are all part of the body of Christ. We walk the Emmaus road every day and the people with whom we share the journey accompany us and we accompany them. The Emmaus road story helps to illuminate *Accompaniment*, a theology of mission. We see that mission is a journey, and that this journey, taken with many companions, shows us the unexpected and sometimes unrecognized Christ who walks with us. In this journey, we break bread together, we move toward Christ's mission of reconciliation between us and God, between us and one another."

Now, anything can become an idol, even a theology. I am not inviting us to worship at the altar of accompaniment, but I do find it a helpful theme and thread for our mission as a synod. Our rostered leaders leaned into accompaniment when we heard from Vance Blackfox at Bishop's Fall Convocation. Accompaniment will be in the background during our three spring regional gatherings (Spokane Valley, Twin Falls, and Ellensburg) where we will talk about *Funding Forward* and stewardship. Most important, accompaniment is what each of our congregations and ministries do locally—you are accompanied by your neighbors, and you accompany them. Accompaniment is sometimes hard, other times joyful, and occasionally puzzling. Our synod staff also seeks to accompany you, whether in the call process, a new adventure, or a time of struggle. The English word synod combines two Greek words that literally mean a way together.

In the life of the church, the other place the word accompaniment arises is of course in worship, during which the instrumentalist accompanies the assembly in singing. This may not be shoulder to shoulder, but what joy we have when the instrument and assembly are in sync! All our accompaniment in the world is grounded in worship. We are both sent from worship to serve, and we return to be fed and nourished. Thank you, finally, for your faithful worship of a God whose love in boundless.

In 2023, I have been extremely grateful for the members of King of Glory who have taken on tasks and volunteered for projects or musical opportunities that they have never done before. I am so supported by volunteers who have gotten excited about different ways to do stewardship or learning about how to serve on the altar guild or how to be a hospitable greeter before worship begins. Our worship volunteers are extremely faithful and welcoming.

I would like to lift up our AV pilots who create slides for our screens and who do the magic of Live Streaming our worship services. They have put hundreds of hours into this ministry and their help expands the number of households that join us for worship online from all over the U.S.

Our Columbarium Committee lost Glen Laushman when he moved and Doneta Stephensen stepped up to take his place. This committee has had a lot to do during 2023 and they are thoughtful and kind to those who are grieving.

Our Sunday School teachers have taught youth on Sunday mornings and put together a Christmas Pageant for our 3 pm Christmas Eve service.

Staff

2023 was a tough year with waiting for many months for our new Director of Music to come to the U.S. and join our ministry. This process dragged out for a long time before we decided that we needed to go a different direction. During our year of interviewing candidates for the Director of Music position and waiting months for our candidate, we had the pleasure of having Del Parkinson be our musician. Del's kindness and his faithfulness, plus his great attitude was a joy. I am so appreciative of his help.

When we decided to change course and let our candidate go, we were able to interview Steve Eulberg, who was ending his time as the interim Director of Music at Covenant Presbyterian Church. Steve was hired and started as our Director of Music on October 1, 2023 and quickly got the vocal choir up and running as well as a chimes choir.

We continue to gather members to be part of short-term Worship planning teams. Each team organizes worship for 4-6 weeks, depending on the liturgical year. This has worked well and several members of our congregation have learned a lot about worship and how to match music, prayers, and scripture together that is based around a theme. Many of the people who have participated in a Worship planning team have seen this as a way to praise God and to prayerfully offer worship to all those who gather.

Our lay preachers continue to be a wonderful addition to our worship team. They understand the responsibility that comes with preaching and they take great care in crafting a sermon. God has truly blessed us with Mary Rickerd, Todd Kraft and Sharlene Harvey.

Our Administrative Assistant, Diana Shafer, resigned at the end of August after being with us for one year. Transitions are hard, but we were able to hire Rebecca Darga who had worked at 3 different churches in the past. Rebecca has been a god-send to us. She takes on new projects and if she has never done them before, she does research and figures out how to complete the task. She is also very welcoming to all who come to KOG. Charlene Etoka continues to serve as our custodian. Charlene is a gift to us as she keeps our church clean and ready for members and visitors.

LEAP Housing

One of the most exciting aspects of 2023 was the congregational approval of partnering with LEAP to have them buy some of our land and build affordable housing in our (God's) backyard. I am so appreciative of the leadership of Mary Rickerd, Todd Kraft and Becky Newberry for heading up this project. Bart Cochran and the other staff from LEAP have come to many meetings with the congregation and with KOG's neighbors to make this project work. LEAP expects to have a ground breaking in the spring of 2024. After many years of talking about what could happen on this land, King of Glory prioritized housing and an additional well to provide water for our neighborhood and to keep our community garden. This is a fantastic way to show love to our neighbors. Thanks be to God!

Confirmation

Cluster Confirmation – It was a joy for me to be part of the Treasure Valley Cluster Confirmation with great colleagues, Pastor Mike Sager, Pastor Meggan Manlove, Casey Cross and Mary Riedl. In June of 2023, King of Glory confirmed Lawson Rocke and Fabrice Maditoloum.

Cluster confirmation disbanded in the summer of 2023 when Pastor Meggan became Bishop Meggan Manlove and Casey Cross ended her time as staff at Hope Lutheran to work as the Assistant Director at Luther Heights.

Luther Heights Bible Camp helped us out by planning and facilitating two confirmation retreats in the fall of 2023 and they will offer 2 retreats in the spring of 2024. Our three confirmation students are: Hudson Rocke, Angeline Boinde and Elaine Mansell (friend of KOG). They attended a day retreat on September 23, 2023 at Immanuel Lutheran Church and an overnight retreat on October 28–29, 2023 in Payette at St. James Retreat Center.

King of Glory hosted "Camp Christmas" in early December which was led by the staff at Luther Heights. This was a Treasure Valley Cluster event for all generations. This event was fun because grandparents brought their grandkids and everyone had a great time. Current confirmation students from various churches had fun making crafts, and doing a quiz game. Kids of all ages were able to paint and decorate a board for an Advent wreath and given candles to take home and have a Advent devotional time at their homes. The ending worship was wonderful with Steve Eulberg playing songs and having us sing along. Leaders read the story of the birth of Jesus and the youth acted it out. This was a great time for all. This event was successful and we are hoping that Luther Heights does this again next year.

Multifaith Action Project (MAP):

Members: King of Glory Lutheran, Covenant Presbyterian, St. Paul Baptist Church and the Church of Jesus Christ of Latter Day Saints.

The Multifaith Action Project hosted a luncheon on May 19, 2023 and invited leaders from the members faith communities as well as leaders from the Boise mayor's office, not-for-profit organizations, the media and community partners. This gave MAP more friends and partners to do the work of feeding people and making connections around housing in our area.

On September 9, 2023, MAP partnered with a national program called "Feed the Hungry" to put together packets of food. MAP gathered 500 volunteers on that day and put together 100,800 packets of food that has been spread throughout the Treasure Valley to faith communities, food pantries and not-for-profits.

On December 16, 2023 MAP gathered people from our member congregations and had a night of prayer and music at St. Paul's Baptist Church. This was a night where we experienced the Holy Spirit among us. The King of Glory members who were a part of the combined choir said that they didn't know they could sing like that.

The initial grant from the Myrtle Collaboration has now ended. MAP continues to have a fund from this grant and we will continue to gather together for joint worship, music and service. The leadership from the partner faith communities will continue to meet and plan how our group can positively affect the Treasure Valley.

Pastor Connie's Continuing Education 2023:

Since I took Godly Play training in 2022, I continue to be updated on how we can use Godly Play in the homes of our families with small children.

I took advantage of the Convergence Lab https://convergenceus.org and watched 11 podcasts with many different speakers who addressed the question, "Can the Church Change?" I have had several conversations with colleagues about this topic and the future of the ELCA and religion in the U.S.

I had time away with ELCA clergy as we discussed the books we had recently read, I was able to be in on a church consultant meeting with a pastor who is a client of the consultant. We also viewed four of the "Can the Church Change?" podcasts and had lengthy discussions about the questions raised in the podcasts and the ideas for change.

I chose to read books on racism, commentaries on various books in the Bible, books written by or about welcoming the LGBTQIA+ community and books written by people who have left organized religion.

President's Report 2023

The Year in Review: reports are regularly posted on the KoG website: https://www.koglutheran.org/council

- Livestream Worship has been a reality now at King of Glory throughout 2023. We recognize and appreciate the efforts of the AV Pilots Team: Wes & Dawn Lewis, Matt Lee, Lisa Kraft, Jim Rickerd, Joel Tompkins and Becky Newberry.
- Our handbells were loaned to Covenant Presbyterian this was a great opportunity to nurture this music ministry at Covenant while we were without a Director of Music Ministry ourselves. Covenant is now able to purchase their own handbells and our 4–octaves were returned to KoG.
- Our LEAP/Veolia Project was approved by our congregation at the mid-year congregational meeting on June 25, 2023. Shortly thereafter, a KoG Task Force was formed to represent the congregation as the decision-making body and liaison between LEAP/Veolia and Church Council. The members are Shirley Engerbretson, Dean Falk, Todd Kraft, Becky Newberry, Mary Rickerd, Mark Stephensen and Carolyn Watts. The services of an experienced attorney, Anne Kunkel, have been secured for the legal contracts work and the required Neighborhood Town Meeting for our neighborhood occurred in November. LEAP has filed with the City of Boise for the creation of the KoG Pocket Neighborhood and we now await the progress and completion of this filing.
- The Fall Stewardship Appeal for 2024 was guided by our affiliation with the Stewardship for All Seasons program. 'Called to Serve, Called to Share' is the theme and statements of intent from the congregation are being received gratefully.
- KoG Staffing Changes included the saga of the search for a Director of Music Ministry which began in late 2022 with the departure of Laurann Taylor. The Personnel Committee interviewed multiple candidates before pursuing the applicant, Brian Copple. An employment agreement was signed in June of 2023 with Brian, but after numerous delays there was also a communication breakdown and KoG Council made the difficult decision in September to release Brian from his employment agreement. The Personnel Committee then reopened their search for candidates and found that Steve Eulberg was interested in this position. Steve was interviewed and hired to begin his ministry as our Director of Music Ministry in October 2023. Concurrently, our administrative assistant, Diana Shafer, gave her notice in September to take a position closer to her home and better suited to her interests. Again, the Personnel Committee sprang into action with interviewing candidates and hired Rebecca Darga, who became our administrative assistant in October 2023.

They will be asked to return their ballots to the Church Office by Wednesday, February 1 to be included in the final count. The Administrative Assistant will collect the e-mailed ballots, redacting names and email addresses. The results will be counted by the Nominating Committee and announced to the congregation.

Financial Reports: Carolyn Jean Smith, Treasurer

Financial Reports were distributed to the congregation.

Due to the resignation of Ashlee Wetherington, King of Glory bookkeeper, accounting services have been contracted with a local accounting firm. Financial procedures have been customized to meet the ability of the firm to maintain the financial system according to good accounting procedures.

2023 Budget Report: Dan Price

The 2023 budget has been reviewed and approved by the Finance Committee and Council. Due to the new accounting firm maintaining financial records, access to the year-end report was delayed so the budget process was slowed.

The 2023 budget is a balanced budget. There have been 70 pledges = \$338,960. There are increases in expenses in 2023 for administrative financial support, accounting services, and salary increases for all staff. Maintenance and utilities have increased because of delayed building maintenance and increased use of the building. Capital improvement has not been included because there are leftover funds from the AV projects (about \$47,000) which can be used for capital improvements (e.g., HVAC, monitors in Narthex/Fellowship Hall or other projects approved by Council and/or congregation.)

MSP (Stan Fornander/Greg Olson) Approve and accept the 2023 Budget.

Due to an oversight on the ballot, Mary Rickerd reported that Nick Tinker and Ian Tompkins had been nominated for the two King of Glory representatives at the 2023 Synod Assembly but were not approved by the congregation in the voting process. The nominations of Nick Tinker and Ian Tompkins as Synod Assembly representatives were approved by voice vote. Greg Olson will be the alternate.

LEAP Affordable Housing

Mary Rickerd reported that the Council has proposed acceptance of Proposal #2 that would be a hybrid housing option with sale of the land to LEAP. Consultation with real estate lawyers and further discussion and negotiations with LEAP are continuing. It is the plan of the Council to keep the Community Garden intact, and continue the process of the sale of property to Veolia for a community well. A special congregational meeting will be called at a later date to consider and vote on the proposals.

MSP (Mary Kay Tinker/Todd Kraft) to adjourn the 2023 Annual Meeting.

After the ballots were collected and secured, Pastor Connie led the closing prayer.



King of Glory Mid-Year Meeting, June 25th, 2023



Motion 1: (a) KOG commits to the building of affordable housing, in partnership with LEAP, on the back property of the church. The project will include the sale of X acres (pending land survey and City of Boise lot split approval) to LEAP to be placed in a Land Trust for the purpose of building eight (8) rental units to be managed by LEAP and its management company, along with a common use space agreement about parking, trash and recycling etc. Details of the sale and common use agreements will be worked out by a Task Force appointed by KOG Council, consisting of up to five members.

(b) KOG commits to the sale of X acre (pending land survey and City of Boise lot split approval) to VEOLIA for the purpose of drilling a new community well on the back property of the church. The project will include the construction of appropriate fencing and an access road to allow VEOLIA access to the well and its associated buildings. Details of the sale will be worked out by the Task Force and approved by KOG Council.

(c) KOG commits to retaining the current community garden with the assurance that water supplies will be available from either the current church well or from VEOLIA. Details of the water access will be worked out by the KOG Property Committee and approved by KOG Council.

Youth Education

- In the spring we continued two Sunday school classes. One for 3 year-olds through 3rd grade, taught by Doneta Stephensen and Coletta Hill. The other was for 4th through 6th grade taught by Phyllis Bradburn and Sharon Grove. Attendance was irregular, but 17 students attended at various times, although a few only once.
- Bible were presented to three 4th and 5th graders.
- For the Cradle Role (Newborns thru age 2) we sent out Splash monthly Newsletters to the parents of 6 children, all who aged out at various times of the year. Now we have a new infant in the church.
- For the children ages 3 -8 we mailed 11 copies of Spark Family every 3 months. We need to keep our list of youth current with birthdates and contact information.
- For 4th thru 6th graders I continued to make tiny books of the Bible, sending 6 or so at a time
 with a lesson sheet about the books to 10 students. There are 14 books left to complete the
 set.
- Two students were confirmed in 2023. 7th to 9th graders are currently attending cluster wide confirmation classes monthly, with Pastor Connie.
- Katie Vaage continues activities with high schoolers and junior high students providing preparation and fund raising for the ELCA National Youth Gathering to be held July 16–20, 2024 in New Orleans with the theme "Created to Be," taken from Psalm 139. A young adult gathering for ages 18–25 has been added since many of them missed the chance to go to the last youth gathering which was cancelled.
- Eight youth, from grades 2 thru high school, attended a week at Luther Heights Bible Camp this summer. For many it was a much-anticipated repeat activity. Katie Vaage, Sally Husted, Gabrielle Applequist and many others in the congregation helped to make this happen.
- In September we held a meeting with parents of Sunday Schoolers to discuss their hopes for their children's Christian education.
- In September we combined the Sunday School classes into one class for ages 3 through 6th grade. We are using the Spark All Kids Sunday school curriculum. The teachers are Coletta Hill, Doneta Stephensen, Phyllis Bradburn and Shirley Dodson.
- In December, Luther Heights provided an inclusive Advent afternoon at King of Glory, for all school age youth from the ELCA churches in the Treasure Valley.
- For the Christmas Eve family service the youth dressed in costumes (from previous years) of the nativity, and were a visible part of the gospel reading. The children concluded the reading with a song.

- Question and Answer sessions about LEAP.
- Pastor Connie has led various classes during the year.

Independent of our committee four Bible studies meet during the week. A Men's Bible study meets each Thursday morning at a restaurant. A Women's Bible study meets each Friday morning. Another Women's study meets twice a month on Wednesday mornings. And on the fourth Monday afternoon of the month women gather with others from local ELCA churches to study the Bible lesson published in the WELCA women's "Gather" magazine.

Other adult opportunities are provided by various groups. A book club meets monthly on a Saturday. And the Christian Life Study group meets on Zoom the first and third Monday afternoons of the month to study a religious life book of their choosing.

Director of Music Report 2023

Equipping the Saints

Since beginning on October 1st, I have been getting better acquainted with the congregation, particularly those who participate in sharing their musical gifts. I conducted an inventory of musical experience and interest in order to revive the Vocal and Chimes Choirs with weekly rehearsals and preparing regular offerings of music for worship. Our bells have returned from their long-term loan to Covenant Presbyterian Church and we're beginning to get acquainted with them again with plans to include them soon.

I am excited to work with musicians in the congregation: Jorgen Vaage (drums) & Ken Grove (organ) to incorporate their gifts in Sunday Worship. I have deep gratitude to Del Parkinson for his leadership over the long interim and as I get acquainted with all the varieties of music that the congregation has experienced and explored, I am also grateful for the long-term leadership of Laurann Taylor who helped to make that possible! I coordinated brass for Reformation & Oktoberfest, and seek to bring a rich and varied approach to instrumental accompaniment, all with the goal of supporting and equipping congregational songs of praise.

I interact with: Church staff, Worship Committee, Worship Planning Teams, and church leadership; I recruit Cantors and program music to include more percussion so that the children and youth can participate regularly in musical accompaniment and leadership. I have recommended and am overseeing the implementation of Planning Center Services software to help the congregation be more easily connected and informed for their worship leadership and responsibilities.

I have been the contact person with AVI-Neurilink for the final installation of the screens in the sanctuary, which we expect to be completed before summer.

Director of Music Report (continued)

I have helped coordinate and provide musical leadership for an Ecumenical Christmas Choir program with St. Paul Baptist, Resurrection Covenant, King of Glory and Jesus Christ of Latter Day Saints members. We were particularly excited to have our Chimes Choir play accompaniment for one of the anthems.

The summary of our faithful monthly service commitments includes interior and exterior building maintenance, roof patrol and groundskeeping. Our budget is broken into these five categories: Inspection/Monitoring, Landscaping, Maintenance & Repair, Supplies, Utilities. We receive monthly reports on expenses from our Church Treasurer, Carolyn Jean Smith. Improvements seen in 2023 include the replacement of a 'vintage' toilet in the women's restroom and the replacement of four HVAC RTU's (Roof Top Units) because cracks were found in the heat exchangers. The remaining seven of the original eleven RTU's are approaching 20 years of age and replacement will become inevitable in the future.

Our building maintenance and inspections include support by several reliable vendors. ACCO Engineering Systems supports the repair and maintenance of the eleven HVAC RTU's. There was an opportunity to combine the inspection services of four different vendors into one contract with Crane Alarm, resulting in an overall contract savings of 25%. Curtis Clean Sweep remains our parking lot support vendor for snow removal and planned resurfacing and restriping after the LEAP/Veolia Projects are completed.

Future contracting work will need to be pursued for summer lawncare and winter snow removal unless we receive more volunteer assistance from our congregation members.

As we have heard before, 'it takes a village' to keep King of Glory a vibrant and active part of our community. We encourage you to consider becoming a part of the Property Committee in 2024. We meet monthly for property task-planning meetings on the second Thursday of the month and we hold Saturday morning Work Days, following that Thursday meeting, between the months of March and November, weather permitting. As an additional perk, Lynda Cambron coordinates food donations and serves a delicious lunch at the end of each Work Day.

Social Ministry 2023

The Social Ministry Committee is focused on helping people in our community and around the world. The congregation has generously supported all of our projects.

In August and September, we asked for donations of school supplies for Lutheran World Relief. We received enough supplies to fill 50 backpacks which were sent out with the hundreds of quilts made by our church members. Any donations that were left over were donated to several local elementary schools and our church members.

We have been collecting eyeglasses for many years which are distributed to other countries by Barbara Blasch. We also collect pop tabs which are donated to Ronald McDonald House. They sell the tabs and use the proceeds to purchase food for their guests who have children in the hospital.

As the Funeral Committee, we purchase, set up and serve food as is needed by the families.

We continued to ask for "Food on the Fourth" where we provide bags for people to take home on the third Sunday and return with food on the Fourth Sunday. This food is donated to the Rescue Mission and local food pantries at the end of each month. We also leave some food at the church for people who might need it.

The Free Meal has provided a meal for people in the community monthly. Twenty-six people volunteered to help this year, some nearly every month. Many meals were eaten or sent home as take-out. In July, a group of young ladies volunteered to help serve and clean up as a service project. Carolyn Jean Smith and Anise Lee head the free meal.

Sandwich Sunday is a branch under Free Meal where 380 to 400 sandwiches are made per month by volunteers and taken to the River of Life/Boise Rescue Mission. The ingredients are donated and volunteers make the sandwiches, which are delivered after church usually by Val and Tom Bridges.

Stewardship 2023

The Stewardship Team would like to report that the first year of participating in the Stewardship for All Seasons program allowed our council to provide the church staff with a pay increase and the purchase of lapel microphones for our worship leaders.

We just completed the second year of the 2-year Stewardship for All Seasons program. This year our appeal for 2024 was Called to Serve, Called to Share! Our goal for 2024 is to increase giving by \$30,000 for:

- ·Automatic front doors, for an entrance that will open to welcome all who are called to serve and share our building. The estimated cost is \$10,000.
- · General Operations, acknowledge the good work of our Church staff with pay increases and funding general building maintenance expenses and upgrades. The estimated cost is \$15,000.
- •Technology Updates, improve our current system to better share our worship service with others and facilitate hybrid classes/meetings to include in-person and remote attendance. The estimated cost is \$5000.

As of 12/31/2023, we have received 49 pledges totaling \$259,592. We are hopeful that additional pledges will come in at the end of 2023.

Last year at this time, 12/31/2022, we received 69 pledges totaling \$333,384.

Due to the need for additional volunteers, we published a new Time & Talent brochure in December. We are hoping to create a larger database for our Sunday volunteers and introduce our new members to ministry opportunities throughout our church.

 Heights from 3-5 days. Many people contributed money, sleeping bags, hygiene items etc. to
 make their week awesome. Thanks to the Bradburns for providing transportation.
- Camp Christmas was held on Sunday, December 3rd for the whole cluster from 1-4
 pm.Closing worship was 3:30 4 pm.A host of crafts were set up in the Fellowship hall along

Mission Endowment Fund (MEF) 2023

As a reminder, last year we moved the majority of the MEF investments to an account in the ELCA Ministry Growth Fund. We do still have a small amount in the Edwards Jones account and a checking account. We currently have about \$196,000 in total among our accounts. Our ELCA Ministry Growth Fund continued to gain back the value we lost in 2022. When we set up this account, we elected to re-invest the dividends back into our account. Most churches take the dividends directly and then use those as their MEF distributions. We have decided to take this approach, update our account as such, as well, and will make distributions for 2023 based on the dividends issued this past year. We are soliciting feedback from the congregation on ideas for recipients of the distributions.

We adhere to the following guidelines for our distributions:

20% - Outreach in the community and our synod

20% - Outreach in North America and throughout the world through the ELCA

20% - Capital improvements or building programs of King of Glory

40% - May be distributed among any of the other three designated areas

We have two areas of focus for the committee this year. First, we would like to develop a thorough policy manual for the committee. We have examples from a valley wide ELCA MEF summit that occurred last October. Secondly, we want to focus on marketing efforts for the MEF. The ELCA has a lot of resources to consider so we hope to make progress on that.
